7. EQ upper loop & lower Climb EQ reroute: Jim/Adrian

Tread is in on EQ reroute. Some finishing and signage posting needed. Will be finished in next few days.

8. Parking lot redesign – unsanctioned jumps: Adrian

- a. Gazebo progress no further information.
- b. Unsanctioned jumps got fixed and gaps filled. The work was done by volunteers.
